# IT TAKES THE POWER OF A GLOBAL NETWORK...

## CHAMPIONING WOMEN'S FUNDS WHO BELIEVE A BETTER WORLD FOR WOMEN AND GIRLS IS A BETTER WORLD FOR ALL

Women's Funding Network is the largest philanthropic network in the world dedicated to improving the lives of women and girls. Collectively our member funds give away more than \$70 million per year and hold \$535 million in working assets. In 2010, we connected and energized our membership of 166 women's and girls' foundations in 26 countries on six continents, which support women-led projects and organizations globally.

In the last decade, it has become widespread knowledge that without the full participation of women and girls our world can neither attain security nor achieve prosperity. For nearly four decades, women's funds have been guided by this knowledge, raising money to support women and girls who are building solutions to the world's most pressing problems.

While there are women's funds all over the world, it takes collective impact to solve the complex, interconnected problems affecting women and girls. Making a positive impact requires a networked approach where women on the ground are connected and strengthened by a global system of robust financial resources, knowledge exchange, and support.

In 2010, Women's Funding Network supported women and girls around the world by growing the financial base of women's funds, uniting women's funds through collaborative actions for systemic impact, and building leadership and capacity to strengthen women's funds.

- Women's Funding Network's Women Moving Millions campaign raised **\$16 million** for women and girls around the world, **bringing the total funds raised since 2006 to \$198 million.**
- We enhanced **Making the Case™** – our social change measurement system that evaluates impact – leading to **an improved experience for over 200 funders and grantees**, including external partners such as the Catalyst Fund, formerly of the Tides Foundation.
- During the Clinton Global Initiative, we made a **\$3 million commitment to Women Moving Jobs** – a program uniting members who fund the most effective strategies to build economic security for women living in poverty in the U.S.
- Our annual conference brought together over **360 participants from 182 organizations** dedicated to building a just and equitable world.
- We testified at the first-ever Congressional hearing to address sex trafficking of children in the U.S. as part of **A Future. Not A Past.** – our campaign to end minor sex trafficking in the U.S. In 2010, the initiative expanded to four states and engaged 33,000 people in online advocacy for national legislation to fund critically needed resources for survivors.

Despite being on opposite sides of the world, women in Africa and North America share similar challenges around domestic violence, the feminization of poverty, and the need for comprehensive healthcare. In North America, member fund Women's Foundation of Minnesota works to improve the lives of women and girls in a fast-changing community of diverse international cultures. To better understand these influences, they connected with African Women's Development Fund (AWDF), a member fund based in Ghana, which supports women's leadership and gender equality in 41 African countries.

In November 2010, staff and donors of the Women's Foundation of Minnesota visited Kenya, Uganda, and Ghana to see how AWDF supports women and girls across cultures and to gain an understanding of how the Foundation can better serve diverse immigrant communities back home. The exchange made clear to Foundation leadership that women's challenges – and solutions – are shared and global.

## GROWING A GLOBAL MOVEMENT TO FUND WOMEN BOLDLY

In 2006, Women's Funding Network partnered with visionary donors Swanee and Helen LaKelly Hunt to launch Women Moving Millions. The campaign has raised over \$198 million in gifts of \$1 million or more to women's and girls' funds in North America, Europe, Africa, and Australia. Women Moving Millions is creating financial fuel for programs on the ground that accelerate women's and girls' abilities to reach their full potential.

In 2010, Women Moving Millions Co-Chairs Helen LaKelly Hunt and Chris Grumm joined hands with women's funds and donors in Australia to launch a localized expansion, Women Mobilising Millions. Australia is a major center for philanthropy that supports social change across the region. For example, International Women's Development Agency (IWDA) – an Australia-based member of Women's Funding Network – is partnering with Wide Bay Conservation Association to restore gender equity in land use decisions in Papua New Guinea. Women there, the traditional custodians of the land, have been increasingly excluded from land development decisions, which can threaten natural resources and undermine community sustainability. To counter this, IWDA is bringing together networks of women to influence land use, as well as to learn new economic skills.

Australia's homegrown Women Mobilising Millions is expanding a global movement of women and men who recognize that without the full involvement of women and girls, efforts to build peace, stability, and equality will fall short.
